## Standing Against Anti-Muslim Hate

*Irving has a documented history of anti-Muslim public demonstrations and political rhetoric, including statements made by public officials in civic settings.*

*If you witnessed or became aware of anti-Muslim rhetoric from a fellow elected official, a candidate, or a public figure in Irving, what would you do, concretely? Would you say so publicly, and if so, how?*

Every Irving resident deserves to live and worship without fear of discrimination. As a Christian, I believe every person is created with dignity, and that principle should guide public leadership.

If I became aware of anti-Muslim rhetoric from a public official or candidate, I would address it directly. My first step would be to speak with the individual and make clear that targeting people because of their faith is unacceptable in a city that serves many religions.

If the behavior continued, I would say so publicly and reaffirm that Irving must be a place where Muslims, Christians, Jews, and people of all faiths are treated with equal respect under the law.

Leadership requires both courage and fairness.

All religious institutions should receive equal treatment under city processes.

If a mosque, Islamic school, or Muslim organization believed their permitting process was delayed or handled inconsistently, I would ask city staff to review the timeline and procedures involved to ensure they were applied fairly.

In Irving's council-manager system, the mayor does not control permitting decisions directly, but the mayor can ask questions, request transparency, and ensure accountability.

If inconsistencies were found, I would support correcting the issue and improving processes so that every religious institution—mosque, church, synagogue, or temple—is treated equally.

Fairness and transparency must guide how city government serves every faith community.

## Opposing Harmful Industries

*The Irving City Council has zoning authority over the location and concentration of alcohol outlets, vape and smoke shops, THC dispensaries, gambling establishments, and sexually oriented businesses.*

*1. When a proposed zoning change raises public safety or community character concerns, what criteria guide your decision?*

*On March 20, 2025, the council voted 6 to 3 to approve Ordinances 2025-47-UDC and 2025-48-ZC (Agenda Items 45 and 46), a rezoning proposal brought by Las Vegas Sands Corporation for 1,001 acres including the former Texas Stadium site. The proposal originally included casino gaming as a permitted use. Sands withdrew that component hours before the vote but stated publicly that without gaming the project makes no financial sense, and they continue to lobby for gaming legalization in Austin.*

*2a. How would you have voted, and do you believe the council adequately weighed the long-term implications of approving zoning that leaves the door open for a casino if Texas law changes?*

*2b. Would you support an ordinance explicitly prohibiting casino gaming as a permitted use within Irving's zoning code?*

### Zhanae Jackson

1. When evaluating zoning decisions, I consider economic impact, public safety, and long-term community stability.

Irving has built a strong reputation as a city for families and professionals. Development should strengthen that stability rather than undermine it.

2a. Casino gambling raises concerns for many residents across faith communities, including Muslims and Christians, because of the social harms associated with gambling addiction.

Because of those concerns, I would have serious reservations about zoning decisions that could open the door to casino development in Irving.

2b. I support economic growth, but it should be growth that strengthens families, neighborhoods, and the long-term health of our city.

1. First and foremost, it is the residents I need to protect. Addictions have been proven to cause severe health issues. Tobacco use and vaping fall in this category. And while alcohol sale is widely available for purchase in Irving, strict regulations exist for various establishments. Proximity of any of these outlets to family neighborhoods or schools must be prohibited. Sexually oriented businesses have no place in our City.

2a. I would have voted No to Casinos in Irving. As I do not participate in the Council work sessions, I do not know if they weighed the long-term implications of an open door discussion for a casino in our City.

2b. Yes, I would support an ordinance explicitly prohibiting casino gambling as a permitted use within Irving's zoning code.

## Moral Courage in Public Life

*For the May 29, 2025 regular council meeting, three addendum items were submitted, including Resolution RES-2025-166, expressing support for the President's efforts to achieve a permanent ceasefire in Gaza and the release of all hostages. The addendum was certified and posted by the City Secretary on Monday, May 26, 2025 by 5:30 p.m., more than 72 hours before the meeting. Before any discussion or vote could take place, all three items were struck from the agenda after points of order were sustained by the presiding officer. Irving Muslims PAC has submitted written inquiries to the City Attorney's Office regarding the legal basis for that removal under Section 5.1(B) of the Council Rules of Procedure, which states that a properly submitted agenda item may only be removed by the member who requested it. As of the date of this questionnaire, no response has been received.*

- 1. How would you have voted on Resolution RES-2025-166, and why?*
- 2. What would you do to ensure that Irving residents and elected council members can bring good-faith items before the council without having them removed on procedural grounds before any discussion takes place?*

1. City residents deserve transparency and open discussion from their elected leaders.

If an agenda item is properly submitted according to council rules, it should be allowed to come before the council for discussion. Preventing debate through procedural maneuvering undermines public trust.

2. While I would review the full context before deciding how to vote on any particular resolution, I believe council members should be able to present good-faith items so the public can hear the discussion and understand where their leaders stand.

As mayor, I would support clear and consistent council procedures so agenda items are handled fairly and residents can see their government operate with transparency and integrity.
